



SBOA Scholarship Award Qualifications & Instructions

The Standardbred Breeders and Owners Association of New Jersey (SBOA of NJ) will award scholarships to qualified students who plan on attending a 4 or 2 year college or university. The following will describe the scholarship and the procedures and conditions for filing an application.

Standards for Consideration

Eligibility:

- Candidates must be either a son or daughter of a full-time participant in New Jersey Harness horse racing OR be a fulltime participant in New Jersey harness horse racing. Only one candidate per household will be considered.

Educational Requirements:

- The applicant must be either a high school senior or attending a 2 or 4 year college/university.
- He or she must have taken the S.A.T. or A.C.T test.
- The applicant must have been accepted or currently attending a college or university

Financial Need:

- Financial need will be assessed based upon the following
 - Parents annual income
 - Special family circumstances
 - The number and educational financial needs of other siblings within the household

Other Consideration:

- An Applicant will be considered, in addition to the aforementioned criteria, based upon the following information:
 - Students involvement in community volunteering
 - Extracurricular academic involvement
 - Evidence of a strong character and leadership skills
 - Interest and pursuance in the equine industry.
 - First consideration will be given to new qualified applicants.

Application Information

Completed Applications must include, in order, the following material:

1. A cover letter
2. Completed SBOA of NJ Scholarship Application.

3. A Letter of recommendation from either a school official or community leader.
4. School transcripts which indicates student's most recent rank in class. If applicant is currently attending a college or university, he or she should include last completed semester report card.
5. Copy of applicant's scores on the College Entrance Examination Board Scholastic Test (S.A.T.) or the American College Testing Program (A.C.T.). (these scores are not necessary for applicants who are already attending a college or university)
6. Parent's most recent Tax return.
7. Any other information the applicant deems relevant to the selection process should be included as an appendix.

Any incomplete applications will not be considered. Applications must be post marked by June 15 and should be addressed as follows:

1. **Obtaining an Application:** Applications will be made available through the following:

2. **Term of Scholarship:** The SBOA of NJ Scholarship is awarded annually and is predicated on continued performance. Applicants are expected to be at least the 75 percentile of their class and perform up to their potential.
3. **Scholarship Amounts:** The award is contingent on the amount of qualified and deserving applicants and financial need. Minimum annual amount is \$2,500.00 with a Maximum of \$5,000.00 based upon the aforementioned conditions. Furthermore, there is a \$10,000 lifetime cap awarded to each individual.
4. **Committees Decision:** The committee will meet on the week of June 20 to review all applicants. A decision will be rendered and applicants will be notified, via mail, at the end of June or first week of July.
5. **Disbursement of Scholarship:** The scholarship amounts will be disbursed to the award winners during the Scholarship Race.
6. **Award Recognition:** All Scholarship winners and families will be invited to a night at the races at Meadowlands; compliments of the SBOA of NJ & BCAP of NJ in recognition of their award. The night will include a race named "SBOA Scholarship Award", Winners' picture in the Meadowlands winner circle, and a complimentary dinner. Dates and times will be determined after selection is completed.
