- 1. This mare is booked specifically by name. The booking is valid for the mare named and may not be transferred without consent of Westwind Farm Canada Ltd.
- 2. Mare owner(s) agree(s) that the mare named in this application shall be healthy and in sound breeding condition immediately prior to breeding. Westwind Farm Canada Ltd. reserves the right to reject any mare not in good physical condition, blind, vicious or unmanageable. This mare must be registered with Standardbred Canada and/or the United States Trotting Association.
- 3. Neither, Westwind Farm Canada Ltd., their owners, members, employees, or agents shall be liable or responsible in any manner for any accident or injury, disease or disability suffered by the mare and/or her foal while at the premises of Westwind Farm Canada Ltd.
